Appendix 6 - Competition Regulations

9. Stopping a Race

- 9.1. Any Race can be stopped at the sole discretion of the Clerk of the Course by ordering the ‘waving’ of the Red Signal at the Start/Finish line. Competitors will be warned that the Race has been stopped by the simultaneous ‘waving’ of the Red Signal at all Flag Marshalling Posts.
- Any Race stopped before the leader has completed two laps will be declared a “No Contest” and available Competitors will restart from their original grid positions (Art.9.2 below also applies).
 - Any race stopped after the leader has completed more than two laps but less than 75% of its duration will be considered as the first part of the race. Competitors will be restarted from a grid set out in the finishing order of this first part which shall be based upon the order of crossing the finish line at one lap less than the number of laps completed by the leader at the time of first showing the Red Signal. Only Vehicles which are proceeding under their own power in accordance with App.8 Art.1.7.j at the showing of the Red Signal (App.7 of this Chapter) will be classified in this first part (Art.49.c and Arts.9.2–9.5 below also apply).
 - If a race covered by Art.9.1.b above cannot be restarted either at that time or later during the same Event for whatever reason then the result will be declared applying the same principle described to produced the grid order at b. above – the order of crossing the finish line at one lap less than the number of laps completed by the leader at the time of first showing the Red Signal.
 - When restarted the result will be the order of finishing at the end of the restarted Race unless Championship Regulations specify otherwise. The result will list all Competitors who took the start in the Race even if they did not take part in the restarted Race and will use the first part for purposes of establishing lap records and point scoring where applicable (Arts.9.2–9.3 below also apply).
 - Any race stopped after the leader has completed 75% of its duration may be considered to have finished unless the Clerk of the Course in consultation with the Stewards of the Event deems it appropriate to restart the Race. The result will be based on the order of crossing the finish line at one lap less than the number of laps completed by the leader at the time of the first showing of the Red Signal.

- f. Only Vehicles which are proceeding under their own power at the showing of the Red Signal will be classified (if restarted Art.9.1.b and d. above will apply).
- 9.2. In the interval between stopping and restarting the Race Vehicles may return to the pit area for repairs. **Having done so they they** may not return to the grid but may join from the pit lane after all the other Vehicles have started.
- Non-runners at the time of stopping must return to the pit lane and may restart from the pit lane behind those referred to above if approved to do so by a Scrutineer.
 - No work may be carried out on the grid unless on grounds of safety and with the approval of an ASN Licenced Scrutineer.
- 9.3. The Clerk of the Course may order that the duration of the second part or re-run of any Race shall be a shorter distance than originally scheduled or may be abandoned altogether.
- ~~If the duration is adjusted by the Clerk of the Course the new duration shall be used for the calculation of 75% under Art.9.1.b and e. above.~~ b. If the first part of the Race was stopped under Art.9.1.a the duration of the re-run will be determined as the duration of the Race.
 - If the duration is adjusted by the Clerk of the Course the new duration shall be used for the calculation of 75% under 9.1.b. and e. above.**
 - ~~However if the first part of the race was stopped under Art.9.1.b then the duration of the second part will be added to the duration of the first part (the elapsed time at which the Red Signal was shown) and the amalgamated figure will be used to determine the overall Race duration.~~

Reason: Clarification. Following cases where the practical implementation of the Race Stop Regulations has been to subject to interpretation the above proposals should provide clarity and ease implementation.

With only one comment received during consultation and following review the Committee agree that no further change to the regulation is needed and requested progression to the Board for Approval.

Appendix 3 - Car and Truck Race Championships

1. Car and Truck Race Championships

- 1.10. If the **Motor Racing Championship Control Panel** agrees in principle with an application for a new **Championship** then the **ASN** will require a Commitment Guarantee Agreement to be executed and delivered in a form satisfactory to the **ASN**:
- (a) for any new A or B Grade **Championships**; and
 - (b) for any new C or D grade Race **Championship** where the **Championship** has not previously been run as a **Series** during the previous year, to demonstrate **Competitor** support and justify **Championship** status.
- 1.11. The Commitment Guarantee Agreement ([Art.1.10 above](#)) must be executed by the **Recognised Club** proposing the new **Championship** and where applicable by the **Commercial** entity proposing the **Championship** through that **Recognised Club** in which case the Commitment Guarantee shall be joint and several.
- 1.12. The Commitment Guarantee Agreement will mandate that if the **Recognised Club** fails to seek a **Championship Permit** renewal by submission of a **Notice of Intent** and or making a **Permit Application** for the second and or third successive years then the **Guarantor(s)** must pay to the **ASN** the relevant sum specified in [Chapter 1 App.2](#) ('the **Default Sum**').
- 1.13. The **Default Sum** shall be paid on demand in writing by the **ASN** accompanied by taxable invoice.
- 1.14. All issued and pending **Championship Permits** of the relevant **Recognised Club** shall be suspended until the **Default Sum** has been paid to the **ASN** or has been provided for to its satisfaction.
- 1.15. All **Default Sums** forfeit to the **ASN** shall be used for the provision of prizes or for training or donation to a **Registered Charity** nominated by the Board of the **ASN**.

Reason: Having undertaken a review of the NCR ahead of the 2026 Championship process it became apparent that when an administrative change was presented and approved by the Board in 2020 amending Championship Guarantee Deposits to Championship Guarantees the format for acceptance had also been changed. This change was not presented to or agreed with Race Committee and is a fundamental change to the consideration of new Championships.

~~2.1. All **Emergency Vehicle Crew** members should attend at least two training sessions a year, at least one of which must be facilitated by an appropriate Motorsport UK registered **Rescue or Recovery Trainer**, as well as several Motorsport UK-permitted **Events** to maintain their efficiency and status. Licensed crew members will not be automatically re-licensed on the basis of attending assessment days only. Training sessions provided by an appropriate Motorsport UK registered **Rescue or Recovery Trainer** may be used as licence signatures. Regional **Rescue or Recovery Trainers** can be contacted via Motorsport UK.~~

2.1. **Rescue** Crew should refer to the **ASN Rescue** Pathway for details of trainee period and requirements and maintenance of licence.

2.2. **Recovery** crew members should attend at least two training sessions a year, at least one of which must be facilitated by an appropriate **ASN** registered **Recovery Trainer**, as well as several **ASN**-permitted **Events** to maintain their efficiency and status. Licensed crew members will not be automatically re-licensed on the basis of attending assessment days only. Training sessions provided by an appropriate **ASN** registered **Recovery Trainer** may be used as licence signatures. Regional **Recovery Trainers** can be contacted via the **ASN**.

Appendix 1 – Rescue Units

Proposed Regulations

5. Crew

5.1 The minimum crew requirements are:

- a. **Rescue Unit: Race and Rallycross Events.** Three ~~fully~~ **Licensed Rescue** crew members holding a minimum of **Rescue Operator Licence** grade, at least one of whom should hold a **Rescue Crew Chief Licence** grade. Immediate medical support must be available from a **Doctor** or **ASN Registered Paramedic** who may attend independently.
- b. **Technical Rescue Unit: Race and Rallycross Events.** Three ~~fully~~ **Licensed Rescue** crew members holding a minimum of **Rescue Operator Licence** grade, at least one of whom should hold a **Rescue Crew Chief Licence** grade.
- c. **Rescue Unit: Rally and Speed Events** only. Two ~~fully~~ **Licensed Rescue** crew members holding a minimum of **Rescue Operator Licence** grade, at least one of whom should hold a **Rescue Crew Chief Licence** grade. Immediate medical support must be available from a **Doctor** or **ASN Registered Paramedic** who may attend independently.
- d. **Technical Rescue Unit: Rally and Speed Events** only. Two ~~fully~~ **Licensed Rescue** crew members holding a minimum of **Rescue Operator Licence** grade, at least one of whom should hold a **Rescue Crew Chief Licence** grade.

5.2. At no time at any **Event** may the crew of a **Licensed Rescue Unit** include more than two **Rescue** trainees or **Rescue** Observers or combination thereof.

5.3. **Licence** application, upgrading and maintenance criteria are detailed in **the Rescue Pathway. Ch.5A App.10 Table 1.1.**

5.4. If no **Rescue** crew member holding a **Rescue** Crew Chief **Licence** grade can attend the event due to unforeseen circumstances, then advice must be sought from the **ASN** through the **ASN Steward** in advance of the stage or event starting.

CHAPTER 18 – KARTING

Proposed Regulations

Chapter 18 – Appendix 8 – Article 34 – Engine

34.11 Engine starter batteries and separate auxiliary data logger batteries where permitted must be fitted to as main **Chassis Frame** or within the confines of the main **Chassis Frame** and shall be placed on the **Chassis Frame** in an area located to the side of the seat opposite the engine and behind the central strut or alternatively mounted on or behind the seat. The battery carrier must be welded directly to the **Chassis Frame** or attached by means of tools **to a minimum of two points on the Chassis Frame and in this case the following apply:**

- **Where attached to a chassis lug the bolt or bolts must be a minimum of M8 size.**
- **When utilising a clamp, all bolts must be a minimum of M6 size.**

Date of Implementation: **Immediate**

Reason: Since the introduction of this regulation partway through this year, it has been recognised that the original wording was open to interpretation that differed from the intention of the original regulation. This is purely a clarification to a new regulation brought in from the beginning of this year, it is not intended to change the requirement but to merely remove the possibility for misinterpretation that has been found since the initial introduction of the regulation.

CHAPTER 18 – KARTING

Proposed Regulations

Chapter 7 – Appendix 9 – Onboard Cameras

1.6 For **Karting** the above provisions apply but the weight of the camera **including any additional casing** (excluding any additional mounting and associated fixing) must not exceed **±200gms**

Chapter 18 – Appendix 8 – Article 36 – Cameras

36.1 Where used cameras must be attached securely to the **Kart** and be approved by the **Chief Scrutineer** and **Event Organiser**. The weight of the camera **including any additional casing** (excluding any additional mounting and associated fixing) must not exceed **±200g**.

Date of Implementation: Immediate

Reason: Following surveying the weights of cameras commonly approved for use in Karting, it has been determined that this regulation requires modification to suit current technology being deployed on Event. Currently, the rules would allow for a camera and a case weighing of 200g or more to be attached to a mounting point. This proposal restricts the maximum mass through any mounting point as 200g representing an improvement In safety.

Proposed Regulations

Chapter 18 – Appendix 7 – Article 3 – Crash Helmets

- 3.1. Crash helmets bearing the **ASN** Approval Sticker must be worn at all times during training and **Practice** and **Competition**.
- 3.2. The user must ensure that the helmet is to a standard specified in the current **ASN NCR** and that it fits and is secured properly and that it is in a serviceable condition. Refer to [Chapter 9](#).
- 3.3. Full face helmets complete with visor are mandatory.
- 3.4. Visors must be manufactured by the helmet manufacturer and must not impede vision.
- 3.5. For helmets with 8858-2010 Helmet M6 anchorages (FHR attachment points), the M6 anchorages must not be fitted in Karting for safety reasons.

Date of Implementation: **Immediate**

Reason: Following the direction of the FIA who have instructed that these FIA homologated devices shown in Article 3.5 cannot be used in Karting for safety reasons. It is a positive safety change which adopts the established FIA international rules into the NCR. This has come from the Executive and has been passed through the Chairs of the Kart and Safety Committee who have not objected to the change and therefore we wish to proceed without consultation and for immediate implementation.

CHAPTER 13 RALLY

Appendix 1 – Regulations Applying to All Rallies including Public Relations and Sound Testing

1. General

- 1.13 Any **Organising Club** or **Promotor** who proposes to establish a new **Stage Rally**, **Road Rally** or **Targa Road Rally**, or **Rally Championship**, must complete an **Expression of Interest** form and submit this to the **ASN Head of Rallying** in advance for ratification. No promotion must take place prior to ratification by the **ASN**.

Date of Implementation: 1st January 2026

Reason: This is a minor amendment to include With the introduction of a licensing scheme for Road Rally Clerks of the Course scheduled for January 2026, any new events should be vetted prior to any promotion taking place

Appendix 4 – Road Events – Routes and Sections

4. Standard Sections

- 4.3 **Standard Sections** must not include any road with a ~~30 or 40mph limit~~ **speed limit of 40mph or lower** without the express permission of the **RLO**.

Reasons:

4.3 – in September 2023, the default speed limit on restricted roads in Wales was lowered from 30mph to 20mph. In line with the recommendation in Paragraph 41 of inquiry J2025/12 regarding the JJ Brown Road Rally, this wording should be updated to better cover the use of restricted roads on standard sections.

Appendix 5 – Road Events Controls and Timing Including Results

6. Results

6.6 Competitors will start with zero fails and/or ~~marks~~ **time penalties**. **Classification** will be made from **Competitors** who have incurred the least number of fails.

- a. **Competitors** who have incurred an equal number of fails will be classified by reference to total ~~marks lost~~ **time penalties accumulated**.
- b. In the event of a tie the **Competitor** who has completed the greater portion of the **Competition** from the **Start** including **Tests** (if any) without **Penalty** (or if both incurred **Penalty** at the same point then with the lesser **Penalty**) will be judged the winner unless another method of resolving ties is specified in the **Official Documents**

Date of Implementation: 1st January 2026

Reasons:

6.6 – No other reference to ‘marks’ is made in the NCR. This update will bring the terminology in line with that used in Chapter 13.

Appendix 9 – Competitors Regulations including Licensing

4. The Crew

- 4.3** ~~Except in accordance with official approval or instructions~~ **The** persons carried at the start must not be varied during the **Event**, unless authorised by the **Official Documents**.

Date of Implementation: 1st January 2026

Reasons:

4.3 – It became clear during a recent Event that the wording under NCR 13.9.4.3 concerning the change of Driver or Co-Driver during an event was ambiguous. Therefore, the wording has been amended to make it clear that the crew cannot be changed once the Event has started, unless authorised by the Event SR's.

Appendix 11B – Specific Regulations for Single Venue Stage Rallies and Rally Time Trials

2. Single Venue Stage Rallies

- 2.5 A Co-Driver who has signed on must be carried in each competing Vehicle, **except Cross Car (XC)** as appropriate.

4. Cross Car (XC)

- 4.4 **Cross Car (XC)** are permitted within approved **Rally Time Trials** and **Single Venue Stage Rally** Events only. All **Events** must gain approval from the ASN prior to advertising the inclusion of these **Vehicles**.
- 4.5 All **Vehicles** must comply with the **Technical Regulations** in Appendix 16 of this Chapter as applicable.
- 4.6 All Crews must comply with the **Regulations** in Apps.10 and 11A

Appendix 16 – Technical Regulations - Special Stage Rally Cars

13. Cross Car (XC)

- 13.1 **Cross Car (XC)** are rear engine 4 wheeled (2 wheel rear drive) single seater **Vehicles** with a multi-tubular spaceframe chassis which must have a safety cage as an integral part of the **Chassis**. The **ASN** have adopted the FIA technical regulation guidelines and these are available upon request.
- a. **XC – Cross Car**. A **Competitor** may participate from their 17th birthday. The minimum **Vehicle** weight with the **Driver** wearing full racing apparel on board and with the fluids remaining at the time the measurement is taken will be 425kg with a recommended vehicle power of 130hp.
- b. **XC Jnr. – Cross Car** are not permitted.
- c. The minimum **Vehicle** weight with neither the **Driver** nor full racing apparel and with the fluids remaining at the time the measurement is taken is 345kg. At no time during the **Competition** may a **Vehicle** weigh less than this minimum weight.

Date of Implementation: **1st January 2026**

Reasons:

App. 11B Art. 2.5, App. 16 Art. 13.1 a-c – These changes and additions are to enable the addition of Cross Cars (XC) to the Vehicles eligible for approved Rally Time Trial and Single Venue Stage Rallies. To be clear, Cross Cars are not permitted on every event and must be approved, via the Rallies Department, prior to their inclusion. Cross Cars (XC) are **not permitted** on Multi-Venue Stage Rallies.

Only Vehicles complying with the current FIA Appendix J 279B (Technical Regulations for Cross Cars) are permitted to compete on specified Rally events. Drivers must be 17 or over to ensure there is clear distinction between existing Junior Rally Championships and Cross Cars with Cross Car Junior Vehicles not permitted at this time.

It is important that we consider all Vehicles in the future of the Sport and Cross Cars will allow Rallying to be accessible to different audiences who may progress within the discipline.

CHAPTER 5A

Appendix 5 – Clerks of the Course

29. Road Rally Clerk of the Course

- 29.1. The **Clerk of the Course** for a Rallying Road, Rallying Road Timed, and Rallying Navigational **Permitted Event** (**Road Rally Clerk of the Course**) must hold a valid **Clerk of the Course Licence** issued by the **ASN** valid for that grade of **Event**.
- 29.2. A **Deputy Road Rally Clerk of the Course** must hold a valid **Clerk of the Course Licence** issued by the **ASN** valid for that grade of **Event**.
- 29.3. An Assistant **Road Rally Clerk of the Course** must hold a valid **Assistant Clerk of the Course Licence** issued by the **ASN** valid for that grade of **Event**.
- 29.4. The maximum number of **Road Rally Clerks of the Course** at any Rallying Road, Rallying Road Timed, and Rally Navigation **Permitted Event** shall be one excluding any **Deputies** or **Assistants**. The **Clerk of the Course** must be nominated as the **Senior Clerk of the Course** responsible for the overall control of the **Event**.
- 29.5. All names on the **ASN Road Rally Clerk of the Course** list will be reviewed annually and may be re-graded.

30. Officiating Capacity

- 30.1. As detailed above and in accordance with Ch.5 but with the following exceptions:
- 30.2. **Assistant Road Rally Clerk of the Course**: May act as **Assistant Clerk of the Course** at **Road Rallies** up to and including **Interclub** status.

30.3. Road Rally Clerk of the Course: May act as a **Clerk of the Course** or **Deputy Clerk of the Course** at all categories of **Road Rally**.

31. First time applications – Assistant

31.1. Only **Clubs** who organise **Road Rallies** may submit a nomination for an **Assistant Road Rally Clerk of the Course Licence**. An applicant's previous motorsport experience will be considered at the **ASN's** discretion.

31.2. The **ASN** requires all applicants to undertake training before the issuing of an **Assistant Road Rally Clerk of the Course Licence**.

31.2. The **ASN** may require applicants to take part in a written or oral examination before the issuing of an **Assistant Road Rally Clerk of the Course Licence**.

32. Upgrading

32.1. Assistant to Road Rally Clerk of the Course

- a. An applicant must follow the **Road Rally Clerk of the Course** modular training programme.
- b. Only **Clubs** who organise **Road Rallies** may submit a nomination for an upgrade of an **Assistant Road Rally Clerk of the Course Licence**.
- c. The **ASN** may require applicants to take part in a written or oral examination before the issuing of a **Road Rally Clerk of the Course Licence**.

33. Grade maintenance

33.1. All **Road Rally Clerks of the Course** are expected to attend at least two out of three consecutive **ASN Clerk of the Course** seminars for which they are eligible.

33.2. The **ASN** may require **Road Rally Clerks of the Course** to take part in a written or oral examination before the re-issuing of their **Licence** each calendar year.

3.14 Applicants for **Road Rally Clerk of the Course Licence** will only be considered if appointed by an **Organising Club** entitled to run such **Events**.

Proposed Regulations

1. Medical Arrangements

~~1.1 All **Doctors** attending motor sport **Events** as **Medical Officers** must be in possession of a valid licence to practice, members of a recognised medical defence organisation and covered by insurance for work outside of a hospital.~~

~~1.2 Foundation Year 1 and Foundation Year 2 doctors may not act as medical officers at an **Event**. Trainees beyond Foundation Year 2 must ensure that the **Approved Practice Setting** restriction has been removed from their licence by the GMC.~~

~~1.3 **Doctors** must be aware that they are expected to provide themselves with the equipment they see necessary for the proper performance of their duties.~~

~~1.4 It is recommended that Doctors should wear readily identifiable (preferably red) protective overalls or tabards. The backs should display the word **Doctor**.~~

1.1 All medical staff must be adequately qualified, have appropriate registration with their professional body, and have a valid suitability check (DBS/PVG) through the **ASN** or subscribed to the DBS Update Service. Details of further requirements are listed below.

1.2 Anyone who has a restriction or sanction on their practice must notify the **ASN**. The **ASN Licence** may be suspended until these are removed.

1.35 Full details of equipment required and duties of the Medical personnel are given in Chapter 10.

~~1.6. The **Anti-Doping Control Official** in conjunction with the **Clerk of the Course** and the **Stewards** may carry out spot checks on **Competitors** or **Officials** to ascertain whether they are using drugs or alcohol (**Chapter 3**).~~

2. Emergency and Medical Officials

2.1 For specific requirements for units and equipment please refer to Chapter 11.

3. Doctors

3.1 All **Doctors** attending motorsport **Events**, must be **ASN** Licensed.

~~3.1 To be **ASN** licensed, applicants must be currently registered with the General Medical Council (GMC) and in possession of adequate valid malpractice insurance.~~

3.2 Anyone who ceases to be **General Medical Council** (GMC) registered will **have their ASN Licence** be removed. ~~from the register.~~

~~3.3 All Doctors attending motor sport **Events** as medical officers must be in possession of a valid **Licence** to practice and be members of a recognised medical defence organisation and covered by insurance. These insurance requirements will normally be provided under the **ASN** Master Insurance Policies.~~

3.3 All **Doctors** must ensure the equipment necessary for the proper performance of their duties is available.

3.4 It is recommended that all **Doctors** should wear readily identifiable (preferably red) protective overalls or tabards. The backs should display the word **Doctor**.

~~3.45~~ All **Doctors** must 'sign-on' and where appropriate produce their **ASN Doctor Registration Licence** card at any **Event** at which they are officiating. They are under control of the **Chief Medical Officer** (where present) and **Clerk of the Course** at all times.

3.6 Doctor Licence

3.6.1 To be **ASN** Licensed, applicants must be currently registered with the GMC with a valid licence to practice, be able to work independently, and be in possession of adequate valid malpractice insurance. New applicants will be required to provide a Form 4 appraisal document and a medical CV.

3.7 Doctor (S) Licence

3.7.1 GMC registered **Doctors** who are no longer Residents and require supervision. Supervision requirements must be discussed and arranged with the **Chief Medical Officer** of the **Event** which they are working at.

3.7.2 To be **ASN** licensed, applicants must be currently registered with the GMC with a valid licence to practice, and be in possession of adequate valid malpractice insurance. New applicants will be

required to provide a medical CV, a Form 4 appraisal document (where an appraisal has been conducted) or a letter of support from their educational Dean.

4. Eligible Paramedics

~~4.1 Eligible Paramedics may be used as detailed in the Specific Regulations.~~

4.1 All **Paramedics** attending motorsport **Events**, must be **ASN** licensed.

6. Medical Assistants

6.2 Radiographers, Physiotherapists and Operating Department Practitioners. To be **ASN** licensed, applicants must be currently registered with the HCPC. New applicants will be required to provide a letter of support from the **Chief Medical Officer** or an **ASN** registered Senior **Doctor** of the venue they will work at confirming their suitability and experience.

6.3. Medical Assistants must 'sign-on' and where appropriate produce their **ASN Medical Assistant Licence** at any **Event** at which they are officiating.

6.4. Medical indemnity insurance is required and will not be provided by the **ASN**.

6.5 They are under control of the **Chief Medical Officer** (where present) and **Clerk of the Course** at all times.

7. Ambulance Crew

7.1 To be **ASN** licensed Emergency Care Assistants (ECAs) applicants must provide a copy of their FREC4 certificate and letter of support from the ambulance provider.

7.2 To be **ASN** licensed Emergency Medical Technicians (EMTs) applicants must provide a copy of their Level 4 Diploma Associate Ambulance Practitioner certificate and letter of support from the ambulance provider.

7.3 Ambulance Crew must 'sign-on' and where appropriate produce their **ASN** Ambulance Crew **Licence** at any **Event** at which they are officiating.

7.4 Medical indemnity insurance is required and will not be provided by the **ASN**.

8. Observer – Medical

8.1 Student **Doctors**, student **Paramedics** and student **Nurses**. To be **ASN** licensed, applicants must provide a letter from the university confirming student status.

8.2 **Paramedics** with less than 2 years since qualification. To be **ASN** licensed, applicants must be currently registered with the HCPC.

8.3 **Nurses** with less than 2 years since qualification. To be **ASN** licensed, applicants must be currently registered with the NMC.

8.4 **Observer – Medical** must 'sign-on' and where appropriate produce their **ASN Observer – Medical Licence** at any **Event** which they are officiating.

9. Observer – Doctor

9.1 GMC registered **Doctors** of Foundation grade (Residents).

9.2 To be **ASN** licensed, applicants must be currently registered with the GMC and provide a letter of approval from their Postgraduate Dean confirming Resident status.

9.3 **Observer – Doctor** must 'sign-on' and where appropriate produce their **ASN Observer – Doctor Licence** at any **Event** which they are officiating.

10. Chief Medical Officer

10.1 The **Chief Medical Officer** grade will be individually reviewed and appointed by the **ASN**.

6.11. Professional Indemnity Insurance

11.1 Professional indemnity insurance is required by the above. Within the range of **ASN** arranged insurances medical malpractice insurance is now provided for volunteer Paramedics (registered with the Health and Care Professions Council) attending **ASN** authorised **Events**. This cover does not extend to any other category of medical personnel. It does not cover those **Paramedics** attending **ASN** authorised **Events** as a result of a commercial contract between their employers and the **Event Organisers**, promoters, or **Venue** owners or operators where the minimum level of required indemnification is £2,000,000 (Samaritan cover is not adequate). Please forward to **ASN** a copy of your insurance certificate in this instance on application.
