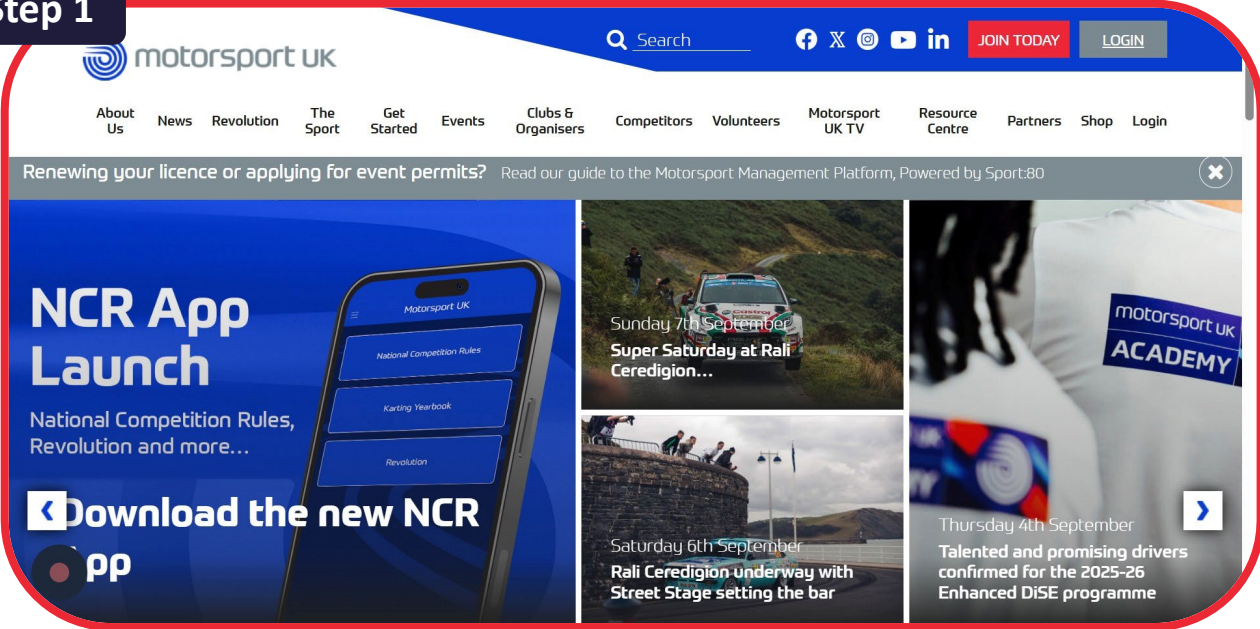

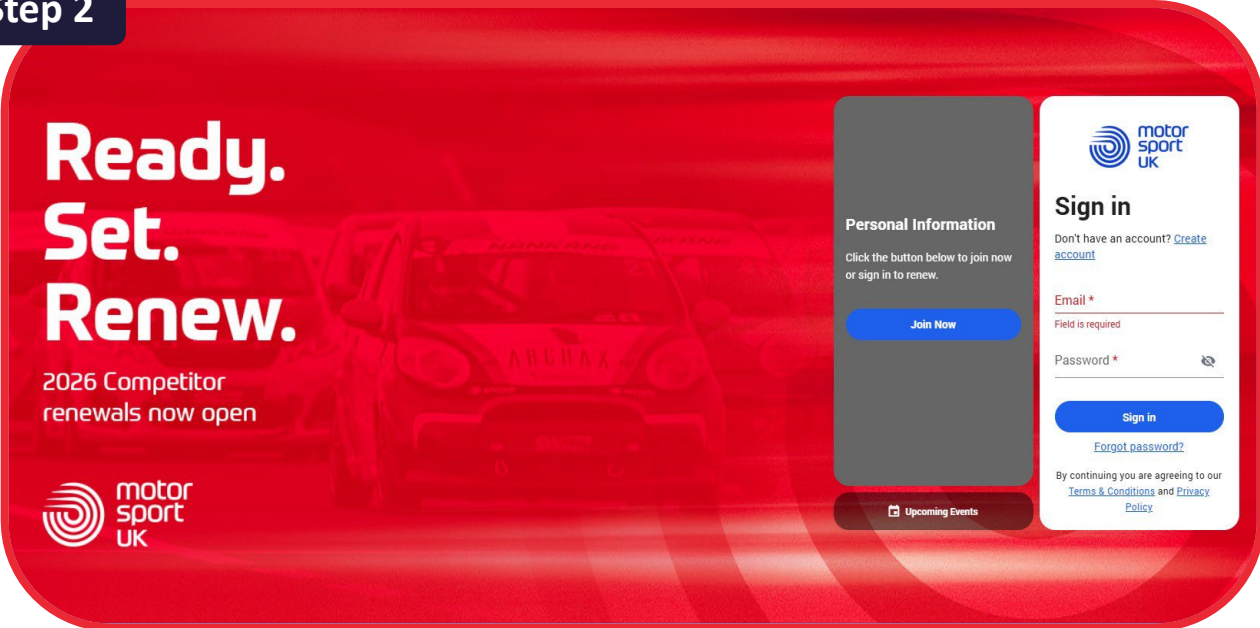

Step 1



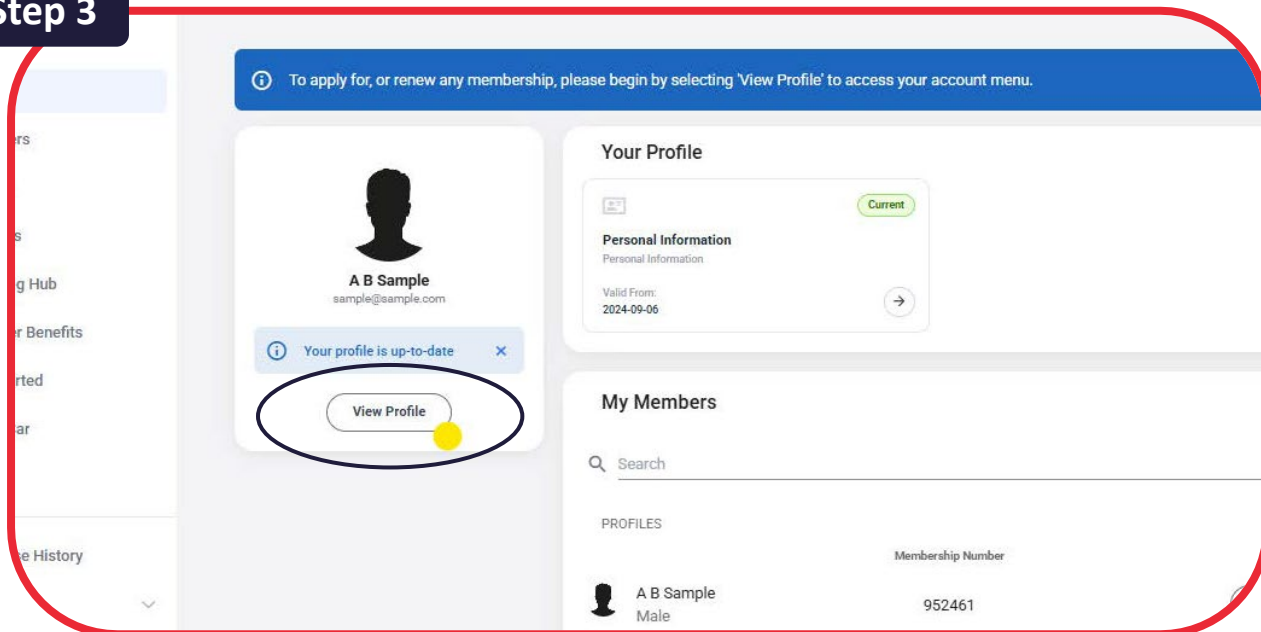
Head to motorsportuk.org and click 'Login' in the top right-hand corner.

Login to your Motorsport UK account. If required, please enter the requested verification code.

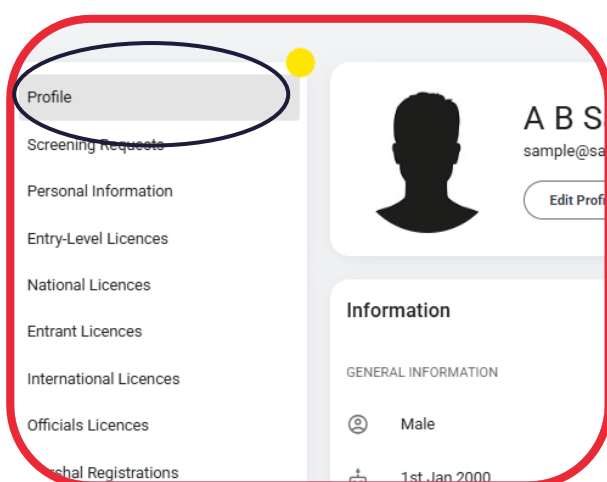
Step 3



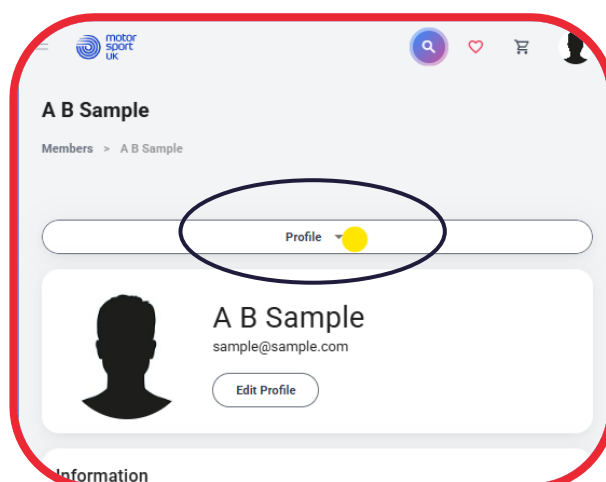
On you account Dashboard/Home Page, please select '**View Profile**'.

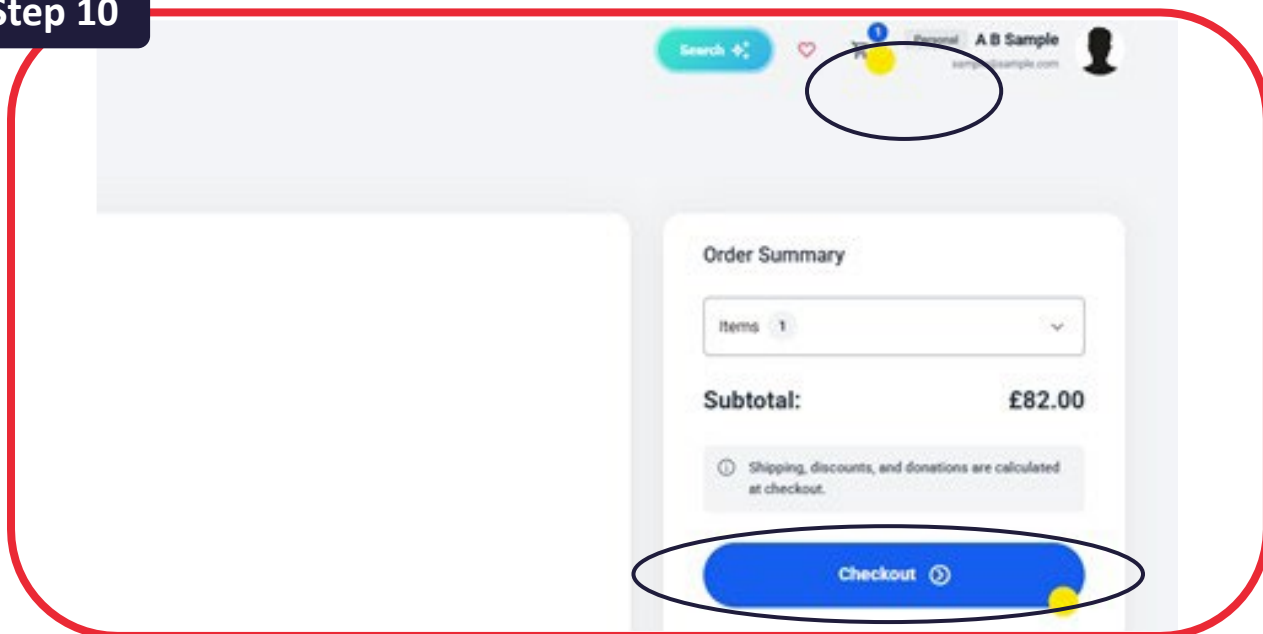
