## Proposed Regulations

### Chapter 2 Judicial Appendix 12 Penalty Points

1.6. Should a Competitor receive twelve (12) penalty points within a ~~rolling twelve (12) month period of twelve calendar months, the Competitors' licence shall be suspended for one (1) calendar month by the ASN. it will result in referral of that Competitor to the National Court by the ASN for consideration of further penalty.~~

1.6.1. During the suspension period, the ASN shall conduct a review of the Competitor's record. This review will result in either:

- Referral to the National Court for consideration of further penalties. In this case, the licence shall remain suspended until the case is considered by the National Court; or
- An order for the Competitor to undertake a driver re-education program. In this case, the licence shall remain suspended until the ASN receives and approves a written report confirming successful completion of the program at which point the licence will be reinstated.

1.6.2. Upon reinstatement of the licence:

- The oldest six (6) of the twelve penalty points used to trigger the suspension shall be removed from the Competitor's record.
- The Competitor's record will be then be reset to 0 (zero) following a two-month monitoring period provided that no further penalty points are imposed.
- Should further penalty points be incurred during this period the points remaining will not be removed and the accumulation of penalty points continue until 12 penalty points have again been reached at which point the Competitor will be referred to the National Court.

1.6.3. If an additional three (3) or more penalty points are incurred during the monitoring period:

- The Competitor shall be subject to a further two (2) month suspension, ordered by the ASN

b) Following this second suspension, all penalty points relied upon for the suspension decision shall be annulled.

- 1.7. The ASN/National Court shall have no jurisdiction to consider the Competitor's guilt in respect of the offences detailed in the relevant endorsements. The form of any further penalty shall be entirely at the discretion of the ASN/National Court.
- 1.8. Unless the National Court makes an Order to the contrary, once any further penalty imposed by the Court has been served by a Competitor the penalty points relied on for that Decision will be annulled.

**Date of Implementation: IMMEDIATE**

**Reason:** During 2025 Motorsport UK has proposed to the National Court a period of driver re-education programme following a review of the drivers record by the Head of Discipline. Having received positive feedback and outcomes from this re-education it is proposed that a more structured and transparent process is included in the NCR.
